JOSHUA TORRENCE FIELD HOUSE DEDICATION

Friends of Joshua Torrence are raising funds to name the new field house at White Knoll High School on his behalf.

Josh was a member of the White Knoll High School football team prior to graduation. He joined the United States Marine Corps and was assigned to the 2nd Amphibian Assault Battalion, 2nd Marine Division.

Josh, who was killed while on patrol in Fallujah, Iraq on March 14, 2005, was the first graduate of White Knoll High School to die serving his country.

Plans are underway to name the field house for Josh at the annual White Knoll High School-Lexington High School football game in November.

Half Staff

There are two days in the year when the American flag is to be displayed at halfstaff: Peace Officers Memorial Day (May 15) and Memorial Day (last Monday in May).

- On Police Officers Memorial Day, the flag is flown at half-staff to remember those law enforcement officers who died in the line of duty. The flag is to be flown at halfstaff all day.
- Memorial Day recognizes the deaths of all veterans whenever they died. Flags are to be lowered to half-staff until 12 noon when they are to be raised to full staff.

The President has congressional authority to order flags to be lowered to half-staff on other important days, such as Pearl Harbor Remembrance Day (December 7th) or Patriot Day (September 11th).

The President or Governor also may order flags to be flown at half-staff for other special occasions. A proclamation is usually issued for those occasions detailing the reason and length of time to be flown at halfstaff.

BEHAVIORAL COUNSELORS FOR DORN

DORN VAMC has been approved for twenty-five new behavioral counselors to work with veterans with PTSD and other psychological issues. DORN has already hired a number of these counselors to deal primarily with Operation Enduring Freedom and/or Operation Iraqi Freedom veterans. These counselors will fill a void in the system, which has seen a large number of veterans experiencing PTSD.

Veterans needing such counseling can contact their primary care physician at DORN VAMC. Veterans not in the VA medical care system need to complete an application to enroll. Check with your local VA office.

DORN EMERGENCY DEPARTMENT

The DORN VAMC now has a 24/7 Emergency Department. This is an emergency care facility only and will not provide after-hours non-emergency care.

If DORN VAMC is used for your primary medical care, advise your family members and/or EMT personnel that you wish to go to DORN VAMC for emergency treatment.

However, veterans needing immediate emergency care should advise family members and/or EMT personnel to take you to the *nearest* emergency medical facility.

Veterans must then notify DORN VAMC within 72 hours of admission that they have been treated in another facility. Dorn will contact the facility regarding any need for transfer to Dorn, payment for emergency services, etc.



SPECIAL EXPOSURE EXAMS

Veterans who have medical symptoms believed to be associated with exposure to Agent Orange, radiation, or asbestos while in service should request an exam at the DORN VAMC. This also applies to Gulf War veterans exposed to environmental hazards.

Go to the C&P office at DORN with your DD-214 or discharge papers and request that you be examined. If you are currently under medical care at DORN, ask your primary care physician to examine you for these conditions.

If the exam shows a diagnosis related to such exposure, contact the VA office to see about filing a claim for service-connected disability.

Joshua Louis Torrence July 26, 1984 – March 14, 2005





Also recognized was the staff of the Veterans Affairs Office who make the van program run smoothly.




OFFICE NEWS

BURIAL DETAIL

COL Frank Whitlock of the SC State Guard briefed the July 2 Veterans Advisory Committee meeting concerning burial details provided by the State Guard. The State Guard has a burial detail that can fold the US flag, play Taps, and provide a rifle salute.

The military services are required to provide at least a two-member detail to fold the flag and present it to the next of kin and play Taps. Due to personnel restrictions, a larger detail to provide a rifle salute are reserved for retired or active duty members. The State Guard is a backup to traditional services with burial details, including the rifle detail, provided when available.


STATE GUARD APPLICATIONS

The SC State Guard is an all-volunteer organization that is a backup to the National Guard. The State Guard has a mission to provide internal security, disaster relief, and protection from civil disorder. The State Guard serves under the Adjutant General of South Carolina.

To qualify for appointment to the SC State Guard, the requirements are:

- Seventeen (17) years of age with parent/guardian consent.
- A US citizen or a resident of South Carolina with intentions of becoming a US citizen.
- Meet height/weight standards
- Meet basic medical condition criteria. (Cannot have a medical condition that could cause injury to oneself or others.)
- No record of Drug or Alcohol abuse.
- An Honorable or General discharge from prior active or reserve military service.
- Cannot be a current member of an active or reserve component of the US Armed Forces.
- A high school diploma or GED and other acquired skills to be enlisted past the grade of private (E-1).
- An Associates Degree and special skills that are required by the State Guard to receive an appointment to Warrant officer or, if two years prior active service, to a commissioned officer.
- A Bachelors Degree to receive an appointment as a commissioned officer or have prior service as an officer.
- A clear police check with no felonious charges or excessive misdemeanors.

BLUE WATER NAVY ISSUES

As of the date of going to press for this issue, the VA has until Friday, July 20 to file an appeal brief on the Haas "Blue Water Navy" decision. Haas, a Blue Water Navy veteran, received a favorable rating at the Board of Veterans Appeals in August 2006, granting him serviceconnection for exposure to herbicides (Agent Orange) in Vietnam. The VA appealed that decision. The file brief expected by July 20 should be the last brief before the matter is adjudicated by the US Circuit Court.

I will be strong when I want to cry and be brave when I want to cower.


