**From the Director...**




Please stop by our office or call to welcome our new Administrative Assistant, Joanne Schirato. We are pleased to have her on board with us and she is honored to work in our Department.

# MILITARY RETIREMENT AND VA BENEFITS



---

Concurrent Receipt means to receive both military retirement benefits and VA disability compensation, and until 2004 this was forbidden by law. To receive a VA disability compensation, disabled military retirees had to waive all or part of their military pay.

## **Concurrent Receipt Overview**

Qualified disabled military retirees get paid both their full military retirement pay and their VA disability compensation. This law phases out (over 10 years) the VA disability offset, which means that military retirees with 20 or more years of service and a 50% (or higher) VA rated disability, no longer have their military retirement pay reduced by the amount of their VA disability compensation. Those Veterans 40% and lower still have the offset because there has been no law passed to eliminate it.

Unlike the Combat Related Special Compensation (CRSC), full concurrent receipt has been phased-in over the last nine years (except as noted above). This means that if you qualify you will see your retirement pay increase incrementally each year until the phase-in is complete on January 1, 2014.

Those members who have been rated less than 100 percent, but rated 100 percent disabled by the VA under the unemployability code (IU), will now receive CRDP. For more information on this please contact the VA at 1-800-827-1000.

## **Concurrent Receipt Eligibility:**

To qualify for concurrent receipt you must:

1. Be a Military Retiree with 20 or more years of service, including:
2. Chapter 61 Medical Retirees with 20 years or more.
3. National Guard and Reserve with 20 or more good years. (Once they turn 60 and begin drawing a retirement check)
4. Temporary Early Retirement Authority (TERA) Retirees may also be eligible.
5. Have a Service Related VA disability rating of 50% or higher.

## **The Value of the CRDP Benefit:**

Your personal CRDP payment rate is determined by your current VA Disability Compensation waiver, minus the CRDP "Table Rate," then multiplied by the current CRDP "Phase Out" percentage. This makes it impossible to create a simple CRDP Payment Rate table that applies to everyone.

When fully phased in, CRDP will fully restore your military retirement pay and VA Disability Compensation payments. For example, a single retiree with a VA Rated service-connected disability could receive their full retirement pay in addition to over \$2,400 a month.

It is also important to note that the amount you receive cannot exceed the sum of your actual military retirement pay and VA Disability Compensation added together.

# **Combat-Related Special Compensation and Concurrent Retirement Disability Pay**

Combat-Related Special Compensation (CRSC) and Concurrent Retirement Disability Pay (CRDP) are programs created by Congress to allow eligible military retirees to receive monthly entitlements in addition to retired pay.

**CRSC** is a special compensation for combat-related disabilities. It is non-taxable, and retirees must apply to their Branch of Service to receive it.

**CRDP** is a restoration of retired pay for retirees with service-connected disabilities. It is taxed in the same manner as your retired pay, and it is normally considered taxable income. No application is required. Eligible retirees receive CRDP automatically provided they are receiving disability at the 50% or higher rate.

The purpose of these entitlements is to recover some or all of the retired pay that military retirees waive for VA disability compensation.

## **Monthly Payments**

Like your retired pay, Defense Finance Accounting Services (DFAS) pays CRDP and CRSC monthly on the first business day of each month. You will receive your CRDP or CRSC payment in the same manner as your retired pay:

1. If your retired pay is being direct deposited into your bank account, VA will do the same for your CRDP or CRSC payment.
2. If your retired pay is sent to you as a paper check, VA will do the same for your CRDP or CRSC payment.

To verify your bank account information or check your mailing address prior to receiving your first payment, you may call Department of Defense Finance (DFAS) at: **1-800-321-1080**.

## **Retroactive Payments**

DFAS and the Department of Veterans Affairs (VA) manage the CRDP/CRSC Processing program (formerly known as VA Retro) to pay eligible military retirees any retroactive CRSC, CRDP and/or VA disability compensation they are owed. A retroactive payment will include any money you may have been entitled to before you received your first monthly payment. A retiree may be due funds from DFAS, the VA or from both agencies. DFAS and the VA remain in communication with each other to successfully establish and process CRDP and CRSC accounts.

DFAS will audit your account to determine whether or not you are due retroactive payment. An audit of your account requires researching pay information from both DFAS and VA. If you are due any money from DFAS, you will receive it within 30-60 days of receipt of your first CRSC or CRDP monthly payment.

If DFAS finds that you are also due a retroactive payment from the VA, they will forward an audit to the VA. They are responsible for paying any money they may owe you.

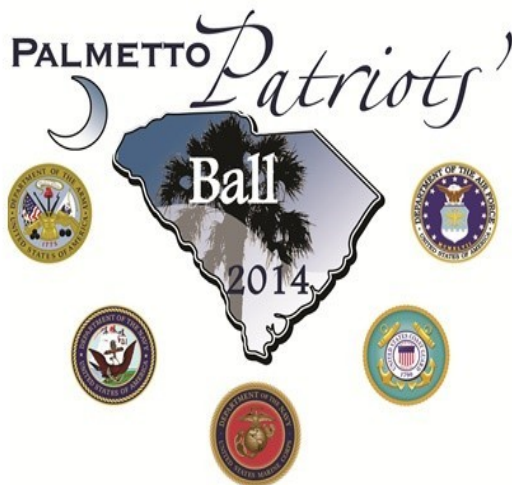

# List of Common Allowable (Recurring) Medical Expenses for an Initial Claim Application

The list below shows recurring VA allowable medical expenses for the initial claim application for pension benefits. The list is not all-inclusive and must be unreimbursed by insurance. They must be paid for by the applicant and are used to reduce outside income that exceeds the VA income limit.

1. Medicare Part B Premiums
2. Medicare Part D Premiums
3. Insurance Premiums for medical insurance
4. Home Health Services
5. Assisted Living Facility Services
6. Nursing Home Services
7. Long Term Care Insurance
8. Medical Monitoring Program (like Life Alert)

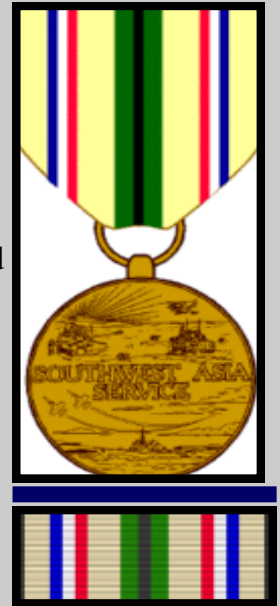
## ***Featured Medal:***

# **Southwest Asia Service Medal**

The Southwest Asia Service Medal (SASM) is a military award of the United States Armed Forces which was created by order of President George H.W. Bush on March 12, 1991. The award is intended to recognize those military service members who performed duty during the years of the Persian Gulf War. The medal was designed by Nadine Russell of the Army's Institute of Heraldry.

Individuals authorized the Southwest Asia Service Medal must have served in support of Operation Desert Shield or Desert Storm, in one or more of the following areas, between 2 August 1990 and 30 November 1995:

- ◇ Persian Gulf
- ◇ Red Sea
- ◇ Gulf of Oman
- ◇ Gulf of Aden
- ◇ that portion of the Arabian Sea that lies north of 10 degrees North latitude and west of 68 degrees East longitude
- ◇ Iraq
- ◇ Kuwait
- ◇ Saudi Arabia
- ◇ Oman
- ◇ Bahrain
- ◇ Qatar
- ◇ United Arab Emirates



Individuals serving in Israel, Egypt, Turkey, Syria and Jordan (including the airspace and territorial waters) directly supporting combat operations between 17 January 1991 and 11 April 1991 are also eligible for this award.

To receive the award, a service member must be: attached to or regularly serving for one or more days with an organization participating in ground/shore military operations; attached to or regularly serving for one or more days aboard a naval vessel directly supporting military operations; actually participating as a crew member in one or more aerial flights directly supporting military operations in the areas designated; or serving on temporary duty for 30 consecutive days or 60 nonconsecutive days, except, if a waiver is authorized for personnel participating in actual combat.

For those service members who performed "home service" during the Persian Gulf War, such as support personnel in the United States, the Southwest Asia Service Medal is not authorized. The award is also not authorized for those who performed support of the Persian Gulf War from European or Pacific bases.

One bronze service star will be worn for participation in each designated campaign. Each recipient of the medal should wear at least one campaign star.
