Introduction to the State and Local Recovery Funds.

The U.S. Department of Treasury is releasing Federal dollars to:

- Support urgent COVID-19 response efforts to continue to decrease spread of the virus and bring the pandemic under control.
- Replace lost revenue for eligible state, local, territorial, and Tribal governments to strengthen support for vital public services and help retain jobs.
- Support immediate economic stabilization for households and businesses.
- Address systemic public health and economic challenges that have contributed to the inequal impact of the pandemic.

The Coronavirus State and Local Fiscal Recovery Funds provide substantial flexibility for each government to meet local needs—including support for households, small businesses, impacted industries, essential workers, and the communities hardest hit by the crisis. These funds can also be used to make necessary investments in water, sewer, and broadband infrastructure.

Tranching of Funds

Local governments will receive funds in two tranches, with 50% provided beginning in May 2021 and the balance delivered approximately 12 months later.

Use of Funds

The Coronavirus State and Local Fiscal Recovery Funds provide eligible state, local, territorial, and Tribal governments with a substantial infusion of resources to meet pandemic response needs and rebuild a stronger, and more equitable economy as the country recovers. Recipients may use these funds to:

- **Support public health expenditures**, by, for example, funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff
- Address negative economic impacts caused by the public health emergency, including
 economic harms to workers, households, small businesses, impacted industries, and the public
 sector.
- Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic.
- **Provide premium pay for essential workers**, offering additional support to those who have and will bear the greatest health risks because of their service in critical infrastructure sectors.
- Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and storm water infrastructure, and to expand access to broadband internet.

Within these overall categories, recipients have broad flexibility to decide how best to use this funding to meet the needs of their communities. Read more at https://home.treasury.gov/

Executive Summary

Lexington County Council is fully committed to using the State Local Fiscal Recovery Funds in a responsible and transparent manner to make the largest impact for the good of the County, its businesses and its citizens. All uses of these funds must receive approval from County Council. Planned uses for the funds are currently being evaluated to ensure adherence to the Department of Treasury guidance. County Council has not committed any monies as of the date of this report. County administration will present all proposed uses of this fund before County Council for approval. County administration will compile the results of the outreach survey and present those results to County Council.

Uses of Funds

a. Public Health (Expenditure Category 1)

Currently under evaluation. Construction of a covered vaccine point/ Rally point training area (or similar building) to provide community services and to prepare our first responders for the current and future community crises. Emergency Services Command vehicle to ensure coordination of continuous emergency operations in current and future times of need.

b. Negative Economic Impacts (Expenditure Category 2)

Currently under evaluation.

c. Services to Disproportionately Impacted Communities (Expenditure Category 3)

Currently under evaluation.

d. Premium Pay (Expenditure Category 4)

Lexington County recognizes the extraordinary effort that its employees gave to continue to provide essential services to our citizens and support their fellow employees on the forefront of the County's response to the Covid pandemic. In recognition of this effort and in accordance with the authorized use of funding from the SLFRF, County Administration is currently developing a premium pay plan for County Councils consideration.

e. Water, sewer, and broadband infrastructure (Expenditure Category 5)

Currently under evaluation. Seek out partnerships with service providers and engage in providing sub grants and monies that will help to expand broadband internet services to our citizen's households and businesses in underdeveloped areas of the County.

f. Revenue Replacement (Expenditure Category 6)

Lexington County has submitted its report as required in the interim report to the Department of Treasury.

Community Engagement

Lexington County will develop a citizen engagement survey to let the County citizen's voice their most urgent and impactful needs that County Council can address within their communities with the use of these funds. The engagement survey will be accessible through the County website and available at the Administration building information desk for citizens who wish to submit their survey in person.

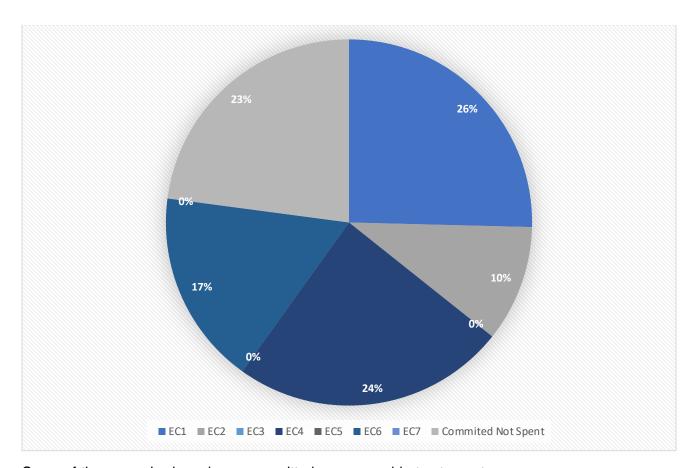
